Through this comprehensive analysis, we create a customized, business-centric strategy and prioritized roadmap with a snapshot of recommendations.

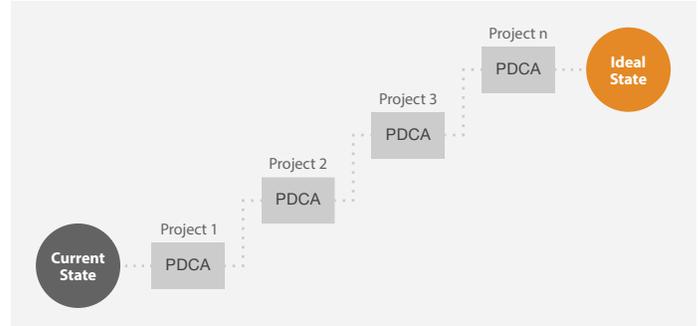
3. Agile Project Plan
